BANKRUPTCY ORDER

UPON the Application of Greenwoods GRM LLP (also known as Greenwood GRM LLP) and formerly known as Greenwoods Solicitors LLP, a creditor, issued the 14th day of February, 2019,

AND UPON reading the Affidavit of Adele Whaley sworn November 21, 2018, the Order of the Honourable Mr. Justice Cavanagh dated February 22, 2021, the Factum and Compendium of the Applicant dated June 2, 2021 and the Consent to Act of the Trustee, Albert Gelman Inc. and hearing from counsel for the Applicant and counsel for the Respondent, Datawind Inc. a.k.a. Jeotex Corporation and a.k.a. Jeotex Inc. having advised that he has no instructions to defend the Application given the lack of corporate authority by anyone on behalf of the Respondent,

AND it appearing to the Court that the following act of bankruptcy has been committed by the debtor, Datawind Inc. a.k.a. Jeotex Corporation and a.k.a. Jeotex Inc.:

- (a) it has ceased meeting its liabilities generally as they become due;

1. **IT IS ORDERED** that **DATAWIND INC. a.k.a. JEOTEX CORPORATION and a.k.a. JEOTEX INC.**, having its registered office in the Province of Ontario, be and is hereby adjudged bankrupt and a Bankruptcy Order is hereby made against the said **DATAWIND INC. a.k.a. JEOTEX CORPORATION and a.k.a. JEOTEX INC.**

2. **IT IS FURTHER ORDERED** that **ALBERT GELMAN INC.**, of the City of Toronto, Province of Ontario, is hereby appointed as Trustee of the Estate of the Bankrupt.

3. **IT IS FURTHER ORDERED** that said Trustee shall forthwith give security in an amount to be fixed by the Official Receiver pursuant to subsection 16(1)(2) of the Bankruptcy and Insolvency Act.

4. **IT IS FURTHER ORDERED** that the costs of and incidental to the within Application to be assessed shall be paid to the Applicant out of the assets of the bankrupt estate as first charge ahead of all secured and unsecured creditors of **DATAWIND INC. a.k.a. JEOTEX CORPORATION and a.k.a. JEOTEX INC.**
